6	ARTICLE 10. DUES DEDUCTION
7 8	Section 1. Upon written request on a form provided by the Union and approved by the
9	University, the Union may authorize the University to deduct regular dues once per
10	month from the paycheck of Union members. The amount to be deducted will be certified by the
11	Union's Treasurer.
12	
13	An authorization to deduct dues shall remain valid until written notice of cancellation is provided
14	to the University by the Union or until the employee is no longer a bargaining unit member,
15 16	whichever occurs first. The Union shall promptly forward to the University notice of cancellations of a dues deduction authorization. Cancellation notices given by the member
10	directly to the University are invalid unless the member has ceased to be a bargaining unit
18	member.
19	
20	Members of the Union who, for any reason, have a break in employment status with the
21	University shall be considered members of the Union on their reinstatement to a bargaining unit
22 23	position with the University, and shall have their dues deducted as members of the Union.
25 24	Section 2. Upon written request from a bargaining unit faculty member on a form provided by
25	the Union and approved by the University, the bargaining unit faculty member may have
26	Political Action contributions deducted from their paycheck.
27	
28	An authorization to deduct Political Action contributions shall remain valid until the bargaining
29	unit faculty member gives written notice to the University canceling the authorization or until the
30 31	member separates from university employment. The bargaining unit faculty member shall also provide a copy of any cancellation notice to the Union. Members of the Union who, for any
32	reason, have a break in employment status with the university and who are reinstated to a
33	bargaining unit position may renew their authorization to have Political Action contributions
34	deducted from their paychecks by submitting the appropriate form.
35	
36	Section 3. The University will send payment to the Union for the total amount deducted with a
37	list identifying the members for whom the deductions are made, the type of deduction, and the
38 39	amount deducted within 10 working days of the deduction being made.
40	Section 4. The Union assumes responsibility for and indemnifies the University for all claims
41	against the University, its officers, officials, employees or agents, arising out of or related to this
42	Article. The Union also will, at the option of the Union, either assume the defense of any such
43	claim or reimburse the University for its incurred defense costs at an hourly rate that is no more
44	than the hourly rate charged by the attorneys representing the Union.
45 46	Section 5 The University will not deduct any Union fines populties, or appoint assessment from
46 47	Section 5. The University will not deduct any Union fines, penalties, or special assessment from the pay of any bargaining unit faculty member.
